

## **“9 years Go For More” PROMO CAMPAIGN PROMO CAMPAIGN TERMS & CONDITIONS**

**1.** The “9 years **Go For More**” Promo Campaign (hereinafter the “Promo Campaign”) is launched by National Bank of Greece S.A. (hereinafter the “Bank”), within the **Go For More** Program (hereinafter the “Program”) and is exclusively for the Members of the Program, pursuant to the following Terms & Conditions.

### **2. Term:**

The Promo Campaign will be launched on 21/03/2024 at 00:00 and will expire on 21/04/2024 at 23:59.

### **3. Participation Right:**

Members signed up to the Program (hereinafter the “Participants”) automatically and exclusively participate in the Promo Campaign, subject to the following conditions being cumulatively met:

- a) They are Members of the Program and maintain their Membership status until the Winners are identified, as defined under term 5.
- b) They make purchases exclusively at the partnered businesses of the Program, during the Promo Campaign, as defined under term 2. The partnered businesses are listed at: <https://www.nbg.gr/go4more/#/partners>
- c) Purchases will be made exclusively using cards issued by the Bank (debit, credit, prepaid cards) that participate in the program.
- d) Members owning any loan product of the Bank are not overdue in paying even one of their loan obligations by over sixty (60) days, up to and including the date the points are credited, as defined under term 7.

### **4. Participation Procedure**

Each Participant earns one (1) participation in the draw for every transaction carried out using a debit and/or prepaid card and two (2) participations for every transaction carried out using a credit card during the term of the Promo Campaign, at partnered businesses of the **Go For More** (<https://www.nbg.gr/go4more/#/partners>) Reward Program and exclusively using cards participating in the Program and issued by the Bank.

### **5. Draw Procedure:**

5.1 The Draw will take place on 10/05/2024 at 16:00 at the Bank’s offices (74 Peiraios St., 18346, Moschato) in the presence of the Bank’s competent officers, with the use of an automated system and specially designed software ensuring the integrity of the process without human intervention.

5.2 Ninety (90) Winners and ninety (90) Runners-up will be drawn. In case of exhaustion of the drawn runners-up, the Bank will carry out a new Draw among the Participants, following a procedure similar to that of the present promo campaign.

### **6. Promo Campaign Prizes:**

100,000 **Go For More** points corresponding to €250 will be credited to each Winner.

The **Go For More** points credited to Winners shall be redeemed under the terms of the **Go For More** Program each time applicable, and shall not be exchanged for money.

## **7. Crediting Points:**

The **Go For More** points of the Draw will be credited to each Winner's Points Account by 15/05/2024.

## **8. Right to Refuse Participation:**

If a Member does not wish to participate in the Draw, they will have to declare so to the Bank by filling out the online Contact Form at <https://www.nbg.gr/en/footer/contact-us> up to two (2) calendar days before the Draw. In the event that they have not declared their refusal pursuant to the conditions hereinabove, they shall be deemed to have accepted their participation in accordance with the present terms.

## **9. Winner with no participation right:**

If the Winner does not meet the conditions outlined in term 3, they cannot receive the draw prize, and their place will be automatically filled by one of the Runners-up in the order drawn.

## **10. Information regarding the processing of your personal data:**

Within the context of this Promo Campaign, the Bank, as Data Controller, collects, maintains and processes personal data of the Participants, i.e identification and contact details, such as are necessary for this Promo Campaign and for purposes related solely and exclusively with carrying it out. The Bank takes every measure to ensure the ethical and lawful collection and processing of personal data, as well as their safekeeping in accordance with the General Data Protection Regulation 2016/679 (GDPR), Law 4624/2019, and the regulatory framework governing implementation of said Regulation, protecting the secrecy and confidentiality of any information it becomes aware of.

Within the context of this Promo Campaign, the Bank shall post the data of the winners (full name and father's name) on its website <https://www.nbg.gr/en/go4more> and on the **Go For More** app. The said details will be available on the Bank's said channels for up to ten (10) calendar days after completion of the Draw. The winners' data shall not be used in future promotion or advertising campaigns of the Bank, but only in the context of this Promo Campaign.

The Bank processes the Participants' personal data as long as this Promo Campaign is valid and, following its completion for as long as required by the statutory and regulatory framework each time applicable.

Last, following confirmation of their identity, Participants are entitled to access their personal data, request amendment of any incorrect or incomplete data, and, if the conditions of the regulatory framework apply, exercise the right to: erase, restrict processing, request portability of their data, challenge the processing of such data, and ensure human intervention in automated processes. To exercise the aforesaid rights, Participants are entitled to submit their request in writing to NBG's Data Protection Officer (DPO) about issues regarding the processing of personal data, addressed to 93 Aiolou St., Athens, GR 10551, Greece, or by sending an email to [dpo@nbg.gr](mailto:dpo@nbg.gr) or by visiting any of the Bank's branches. In the event that they believe that the protection of their personal data has been compromised, Participants can refer the matter to the Hellenic Data Protection Authority.

## **12. Applicable Law:**

Any dispute arising from the interpretation or implementation hereof shall be settled by the Courts of Athens, Greece, and shall be governed by Greek law.
