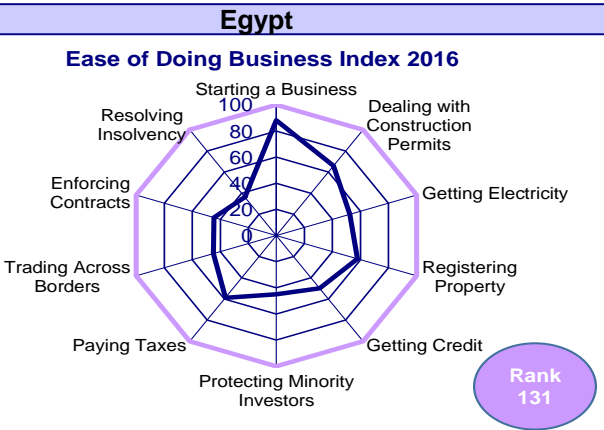
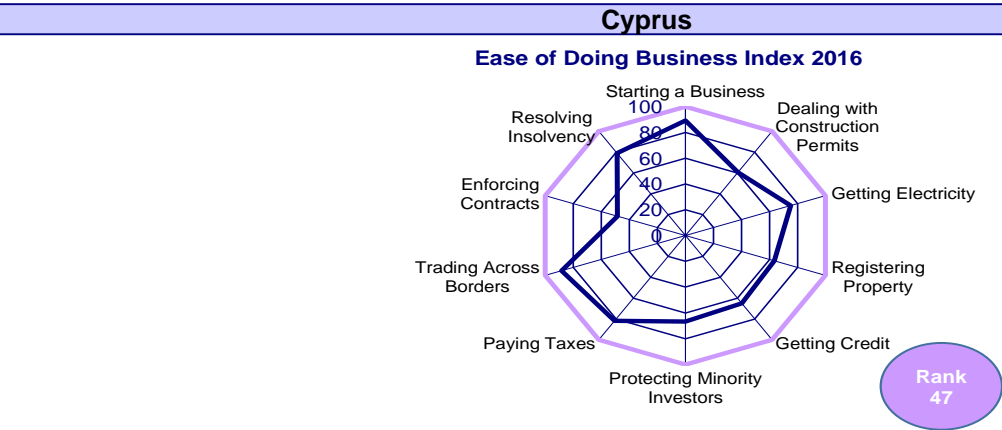
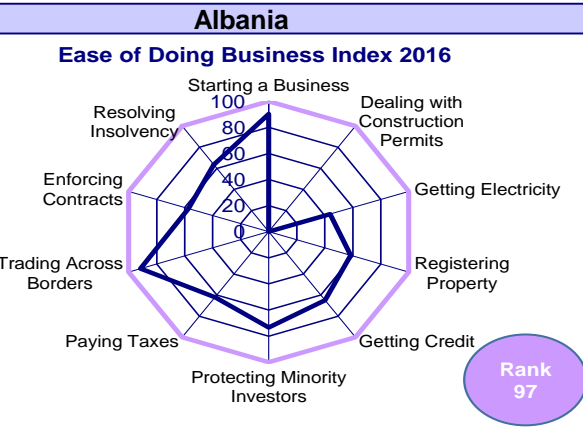
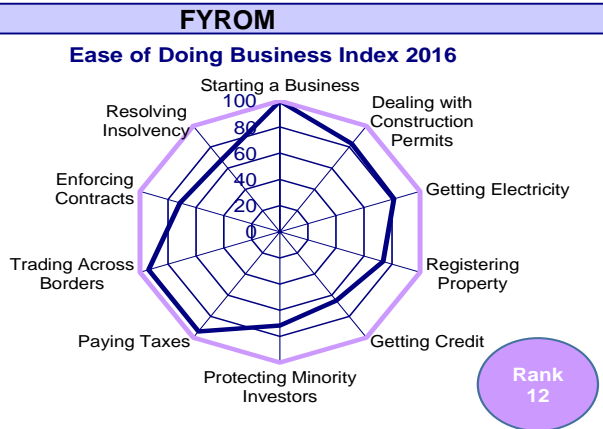
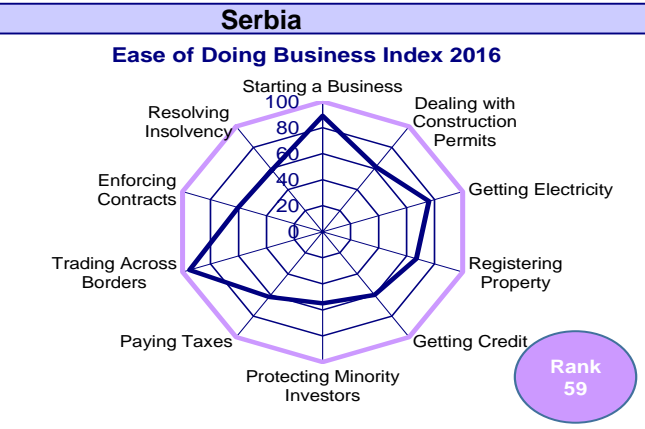
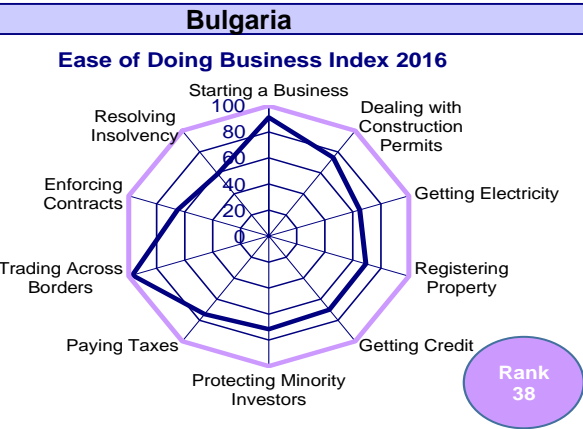
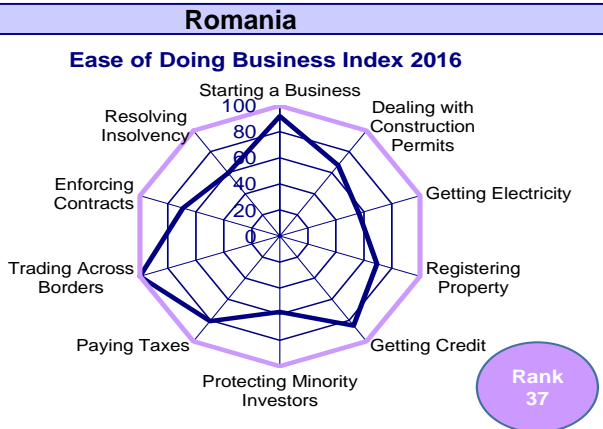
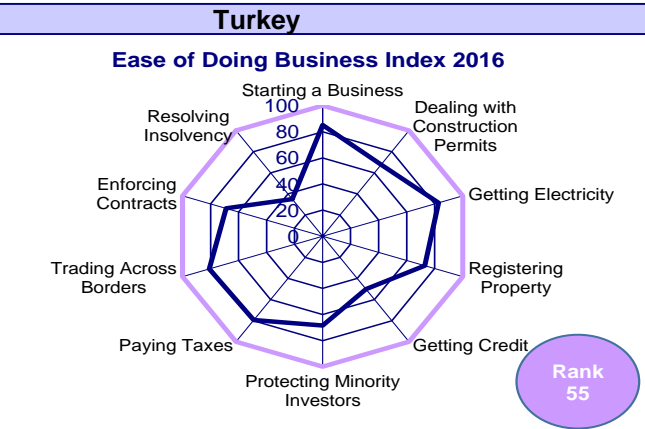
Global Competitiveness Index 2015-2016* (World Economic Forum)

Gross Wages in Manufacturing (y-o-y % change)



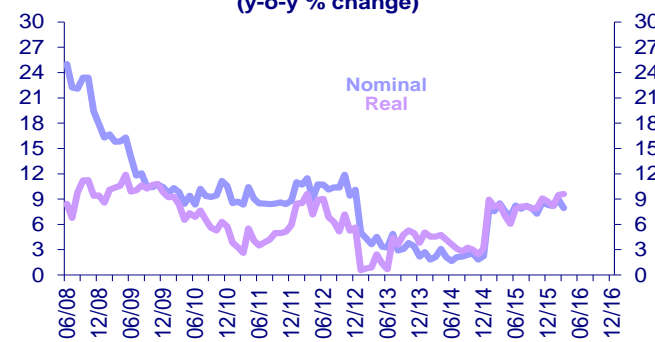
