All sealed envelopes should be submitted to the competent auction Committee on the date and time that the auction is held, either in person or by a legally authorized representative.

After the sealed bids are opened, Ethniki Insurance reserves the right to award the property to the highest bidder, or to ask the highest bidder, or all the bidders including the highest one or some of the bidders, according to their ranking (depending on the amount of their bids) to improve their bids. Thereafter, the auction shall immediately continue, until the winning bidder is selected, by submitting open bids and counter-bids, which shall be signed by the bidders and recorded in the minutes. The minimum bid and counter-bid for each of the above properties is stated in the Terms for Lease of each property, of which the potential bidders shall be aware.

Before finalization of the auction, the winning bidder shall adjust, if necessary, his deposited guarantee as set out in the relevant General Terms for the Lease of each property, supplementing the said amount with a banker's draft to the order of ETHNIKI INSURANCE or with a Letter of Guarantee issued by a bank, to secure observance of the auction terms, but in no event shall this mean that the property is conclusively awarded.
